RE: Amendment to License Agreement dated March 27, 2009, between Thomas McMurchie as licensor and Compound Fun, LLC.

Dear Ray:

I am writing to confirm our verbal agreement regarding the License Agreement and the property and rights relating to the game known as Tsuru. Please execute and accept this signed letter as an amendment to our original License Agreement dated March 27, 2009 where:

1. The License Agreement is amended effective today April 19, 2011.
2. Throughout the term of the License Agreement the Licensor hereby transfers and assigns to Compound Fun, LLC all of the following (the "Transferred Property"), free and clear of all liens, encumbrances and restrictions of any kind and Compound Fun accept such assignment:
  - a. Any copyright, trademark, to include, but not limited to the trademark registration 2,978,453, trade dress, good will or other proprietary rights in the Products, or associated with or arising from the creation, manufacture, sale, or use of the Products throughout the entire world in all media, including any rights in any improvement of the Licensed Property or Licensor Rights, or derivative works based on the Licensed Property or Licensor Rights, shall belong solely and exclusively to Compound Fun. All derivative works shall remain property of Compound Fun after the termination or expiration of this agreement.
  - b. Licensor hereby assigns to Compound Fun all rights Licensor has or may acquire in any copyright, trademark, to include, but not limited to the trademark registration 2,978,453, trade dress, good will, or other form of intellectual property associated with or arising from the creation, manufacture, sale, or use of the Products throughout the entire world in all media, including any rights in any improvement of the Licensed Property or Licensor Rights, or derivative works based on the Licensed Property or

Licensor Rights. This includes but is not limited to all rights associated with or arising from the name or mark Tsuro.

3. Throughout the term of the License Agreement the Licensor hereby conveys and assigns to Compound Fun, LLC all personal property comprised of Production Assets, including but not limited to all art, molds, tooling, inventory and promotional materials. Licensee shall promptly deliver all such property to Licensee or its designee.

4. At any time, upon Compound Fun's reasonable request, Licensor shall execute such further documents as Compound Fun may deem reasonably necessary to effectuate the assignments set forth in this letter, or to assist Compound Fun, at Compound Fun's expense, in protecting or preserving Compound Fun's rights in the Products, Licensor Rights or Licensee Rights.

5. Licensor agrees that it will not contest, cause any other party to contest, or assist any other party in contesting, the title to or any rights of Compound Fun in and to the Products, Licensor Rights or Licensee Rights.


