RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **April 29, 2010** (this "Release") is made by U.S. Bank National Association, a National Association, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain Security Agreement, dated as of **July 11, 2006** and recorded on **September 26, 2006** in Reel **3397 Frame 0030**,* in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **O'Gara Safety and Security Institute, Inc.**, (the "Debtor") and the Secured Party;

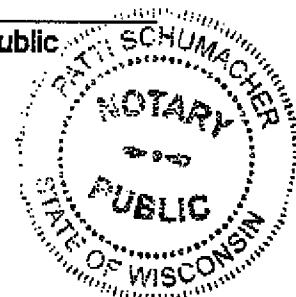
