THESE ARTICLES OF CONVERSION are made and executed effective as of the 2nd day of September, 2009, by the undersigned, a duly authorized officer of HUNTSMAN GROUP INTELLECTUAL PROPERTY HOLDINGS CORPORATION, a Utah corporation (the "Corporation"). These Articles of Conversion have been duly executed and filed in accordance with Section 16-10a-1008.7 of the Utah Revised Business Corporation Act (the "URBCA") and Section 48-2c-1401 of the Utah Revised Limited Liability Company Act (the "URLLCA").

RECITALS:

- A. The Corporation was incorporated by the filing of Articles of Incorporation with the Utah Division of Corporations and Commercial Code on March 31, 1995.
- B. The purpose of these Articles of Conversion is to convert the Corporation from a domestic corporation to a domestic limited liability company.
- C. The name of the Corporation immediately prior to conversion is HUNTSMAN GROUP INTELLECTUAL PROPERTY HOLDINGS CORPORATION.
- D. The name of the Corporation after the conversion, as set forth in the Articles of Organization, is HUNTSMAN GROUP INTELLECTUAL PROPERTY HOLDINGS LLC.
- E. The Corporation currently has issued and outstanding 30,000 shares of common stock, 10,000 shares of Class A Stock and 10,000 shares of Class B Stock. In connection with the conversion, each share of capital stock, regardless of class or series, shall be converted into one membership interest in the limited liability company.
- F. These Articles of Conversion have been approved by the stockholders of the Corporation in accordance with Section 16-10a-1008.7(c) of the URBCA and Section 48-2c-1404 of the URLLCA.
- G. The effective time and date of these Articles of Conversion shall be 10:33 a.m. (Central Time) on September 2, 2009.
