TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of February 24, 2011 (the "Effective Date"), by and among Focused Health Solutions, Inc., an Illinois corporation ("FHS"), Unity Health Management Company, a Delaware corporation ("Unity" and, together with FHS, the "Assignors"), and Optimal Benefit Services, Inc., a Delaware corporation ("Assignee"). Capitalized terms used but not otherwise defined herein shall have the meaning given to them in the Purchase Agreement.

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of February 3, 2011 (as amended, the "Purchase Agreement"), by and among the Assignors, Assignee and, for the limited purposes specified therein, Health Fitness Corporation, a Delaware corporation and owner, beneficially and of record, of all of the issued and outstanding capital stock of Assignee, the Assignors have agreed to sell, and Assignee has agreed to purchase, the Assets; and

WHEREAS, pursuant to the Purchase Agreement, the Assignors wish to assign to Assignee, and Assignee wishes to acquire from the Assignors, the United States trademark registrations set forth on Schedule A attached hereto, together with the goodwill of the business associated therewith (collectively, the "Marks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignors hereby sell, assign, transfer and set over to Assignee the entire right, title and interest in and to the Marks, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignors if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

The Assignors shall take all further actions, and provide to Assignee, Assignee's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation) requested by Assignee to more fully and effectively effectuate the purposes of this Assignment, including, without limitation, with respect to the following: (1) the preparation and prosecution of any application for registration, or any application for renewal of a registration, relating to any of the rights assigned herein; (2) the prosecution or defense of any interference, opposition, infringement or other proceedings that may arise in connection with any of the rights assigned herein, including, without limitation, testifying as to any facts relating to the Marks and this Assignment; (3) obtaining any additional trademark protection relating to rights assigned herein that Assignee reasonably may deem appropriate that may be secured under the laws now or hereafter in effect in the United States or in any foreign country; and (4) in the implementation or perfection of this Assignment in all applicable jurisdictions throughout the world, in each case, all on the terms and subject to the conditions set forth in the Purchase Agreement.

The Assignors hereby request the Commissioner of Patents and Trademarks to record Assignee as the assignee and owner of the Marks.


