
Re: Submission to Correct Previous Erroneous Submission

Registrant, Ellis Coffee Company, requests that the assignment record of the U.S. Patent and Trademark Office be corrected in view of the attached previously recorded documents that erroneously affect the following identified registrations. The recorded July 22, 2008 letter refers to a certain Trademark and Tradename Security Agreement and Mortgage by and between Registrant and THE CIT GROUP/COMMERCIAL SERVICES, INC. ("CIT") that incorrectly refers to as an Assignment rather than a "Security Agreement."
