I, the undersigned, hereby declare as follows:

1. I hold the office of Assistant General Counsel in the Legal: Global Trade Marks Department with the current Owner company, GlaxoSmithKline LLC. In performing my duties for GlaxoSmithKline LLC, I have knowledge of its activities and of its trademark usage and trademark rights, and its control over the nature and quality of the goods and services offered under its marks;
2. The mark, ESKALITH CR and corresponding Reg. No. 1263366, is currently in the name of GlaxoSmithKline LLC.
3. Change of name of ownership of the mark ESKALITH CR, which was recorded at Reel No. 4106/Frame No. 0953 from SmithKline Beecham Corporation to GlaxoSmithKline LLC, was inadvertently submitted with erroneous information. The correct and current owner of ESKALITH CR remains Noven Therapeutics, LLC having a business address of 11960 S.W. 144 Street, Miami, Florida, 33186 as reflected in the change of name dated January 15, 2008, recorded on Reel No. 3696/Frame No. 0502.

No. 1263366, which should not be considered altered by the incorrect change of name submitted on December 2, 2009.
