RELEASE OF SECURITY INTEREST IN TRADEMARKS

FOR VALUE RECEIVED, the undersigned, WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, successor-by-merger to Wachovia Bank, National Association (the "Secured Party"), hereby releases any and all liens on and security interest in the Trademark Collateral (as defined below) granted and pledged to it by ROCK-TENN SHARED SERVICES, LLC, a Georgia limited liability company (the "Grantor"), pursuant to that certain U.S. Security Agreement (Non-Shared Collateral) dated as of March 5, 2008, between the Secured Party and Grantor (as previously or subsequently amended, modified or supplemented) ("Security Agreement"), WITHOUT ANY REPRESENTATION OR WARRANTY OF TITLE AND WITHOUT RECOURSE, all liens on and security interest in, (i) the trademarks and trademark applications secured under the Security Agreement, including the trademarks and trademark applications listed on Schedule I hereto ("Trademarks") (ii) all renewals thereof, (iii) all goodwill of the Grantor's business connected with and symbolized by the Trademarks, (iv) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect to the Trademarks, including without limitation, damages and payments for past or future infringements thereof, (v) the right to sue for past, present and future infringements of the Trademarks, and (vi) all rights corresponding to the Trademarks throughout the world (collectively, the "Trademark Collateral"), and subject to the Notice of Grant of Security Interest in Trademarks recorded on behalf of the Secured Party by the United States Patent and Trademark Office on March 12, 2008, at Reel 003737, Frame 0876 and the Notice of Grant of Security Interest in Trademarks recorded on behalf of the Secured Party by the United States Patent and Trademark Office on September 27, 2005, at Reel 003169, Frame 0441.

The Secured Party shall, at Grantor's sole cost and expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this release.
