of the General Corporation Law of

Kadient, Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware (the "DGCL"),

DOES HEREBY CERTIFY THAT:

1. The name of the Corporation is Kadient, Inc. (f.k.a. Pragmatech Software, Inc.)
2. The Corporation filed its original Certificate of Incorporation with the Secretary of State of Delaware on June 5, 2003. The original Certificate of Incorporation was amended by a Certificate of Amendment filed with the Secretary of State of Delaware on December 20, 2004, by a Certificate of Amendment filed with the Secretary of State of Delaware on June 30, 2006, by an Amended and Restated Certificate of Incorporation filed with the Secretary of State of Delaware on December 6, 2006, by a Certificate of Amendment filed with the Secretary of State of Delaware on October 1, 2007, by a Certificate of Amendment filed with the Secretary of State of Delaware on December 22, 2008, by a Certificate of Amendment filed with the Secretary of State of Delaware on April 15, 2009, by a Second Amended and Restated Certificate of Incorporation filed with the Secretary of State of Delaware on May 28, 2010 and by a Certificate of Amendment filed with the Secretary of State of Delaware on November 12, 2010, (as amended, the "Certificate of Incorporation").
3. The Board of Directors of the Corporation duly adopted a resolution, pursuant to Section 242 of the General Corporation Law of the State of Delaware, setting forth the following amendments to the Certificate of Incorporation and declaring said amendments to be advisable. The stockholders of the Corporation duly approved said proposed amendments by written consent in accordance with Sections 228 and 242 of the General Corporation Law of the State of Delaware.
4. The Certificate of Incorporation is hereby amended by deleting Article FIRST in its entirety and inserting the following in lieu thereof:  
  
"**FIRST**: The name of the corporation (the "Corporation") is Qvidian Corporation.
