ASSIGNMENT OF TRADEMARKS

WHEREAS, pursuant to the Amended Chapter 11 Plan of Reorganization for Debtor, Assignor (the “**Plan**”) confirmed by the Bankruptcy Court for the Eastern District of Pennsylvania (the “**Bankruptcy Court**”) on April 19, 2011 (the “**Confirmation Date**”), the Bankruptcy Court authorized Assignor to assign the Trademarks to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor, intending to be legally bound, agrees as follows:

Assignor does hereby assign and transfer to Assignee Assignor’s entire and undivided right, title, and interest in and to the Trademarks, together with all the associated goodwill of its business symbolized thereby and all applications and registrations of the Trademarks, as well as all rights to injunctive relief, damages, and profits, due or accrued, arising out of all causes of action, past, present and future, including infringement of the Trademarks, or other violations, or injury to the said goodwill, and the right to sue for and recover the same in Assignee’s own name and the names of Assignee’s successors, assigns or other legal representatives; the same to be held and enjoyed by Assignee for its own use, and for its successors, legal representatives, and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment of Trademarks not been made.
