## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Assignment"), dated as of May 31, 2011, is made by ContinuumLink Health Technologies, LLC, a Delaware limited liability company (the "Assignor") in favor of ContinuumLink, LLC, a Delaware limited liability company (the "Assignee").

### RECITALS:

WHEREAS, pursuant to the terms and conditions of an Asset Purchase Agreement, of even date herewith (the "Purchase Agreement"), by and among Assignor, Assignee and the other parties named therein, Assignor wishes to sell, convey, assign, transfer and deliver to the Assignee all of Assignor's right, title and interest in and to the intellectual property set forth on Schedule A attached hereto (collectively, the "Intellectual Property"); and

WHEREAS, Assignee wishes to acquire, and Assignor wishes to transfer Assignee, all right, title and interest in and to the Intellectual Property.

NOW, THEREFORE, in consideration of the mutual covenants and premises set forth herein and in the Purchase Agreement, and for other good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, Assignor hereby sells, conveys, assigns, transfers and delivers to Assignee all right, title and interest in and to the Intellectual Property, together with the goodwill of the Business (as defined in the Purchase Agreement) in connection with which the Intellectual Property is used, and all rights to collect royalties, products and proceeds in connection therewith, all rights to sue and bring claims for past, present and future infringement and misappropriation or other violation thereof, and all rights to recover damages (including attorneys' fees) in connection therewith, together with right to file for and own any and all renewals and extensions of the registrations for the Intellectual Property that may be secured under any applicable law now or hereafter in effect.


Assignor will provide to Assignee all reasonable cooperation and assistance (including the execution and delivery of any and all affidavits, declarations, oaths and other documentation, and the delivery of any and all samples, exhibits, specimens and the like in the control of Assignor) requested by Assignee to effectuate the purposes of this Assignment.

This Assignment shall be construed in accordance with, and governed by, the laws of the State of Florida without regard to its rules regarding conflicts of law.
