2. The Assignor shall at the request and expense of the Assignee do and execute or procure that there shall be done and executed all such documents, deeds, matters, acts and things as the Assignee may at any time reasonably require properly to vest the Trade Mark in the Assignee or otherwise to give the Assignee the full benefit of this assignment.
3. This assignment shall be governed and construed in accordance with the laws of England and Wales and each party agrees to submit to the exclusive jurisdiction of the courts of England and Wales.
