RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release") is given as of this 3rd day of June, 2011, by ING CAPITAL LLC, as Collateral Agent ("Assignor"), in favor of WNC INSURANCE HOLDING CORP., a Delaware corporation, located at 135 South LaSalle Street, Suite 3914, Chicago, IL 60674, WILSHIRE NATIONAL INSURANCE AGENCY OF TEXAS, INC., a Texas corporation, located at 899 El Centro Street, South Pasadena, California 91010, PRECISE ADJUSTMENTS, INC., a Texas corporation, located at 4101 McEwen, Suite 300, Dallas, Texas 75244, WILSHIRE NATIONAL CORPORATION, a California corporation, located at 899 El Centro Street, South Pasadena, California 91010, INSURANCE MANAGEMENT SERVICES, INC., a Wisconsin corporation, located at 120 Bishops Way, Suite 128, Brookfield, Wisconsin 53005, WNC INSURANCE SERVICES, INC., a California corporation, located at 899 El Centro Street, South Pasadena, California 91010, and WNC ACQUISITION, INC., a California corporation, located at 899 El Centro Street, South Pasadena, California 91010, (each an "Assignee", and collectively, "Assignees").

Capitalized terms used in this Release, but not defined herein, shall have the respective meanings ascribed to them in the Pledge and Security Agreement.

WHEREAS, reference is made to that certain Credit Agreement, dated as of January 8, 2004, (as it may have been amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among WNC Acquisition, Inc., a California Corporation (the "Company"), the lenders party thereto from time to time (the "Lenders") and ING Capital LLC, as Administrative Agent;

WHEREAS, in consideration of the extensions of credit and other accommodations of Lenders as set forth in the Credit Agreement, each Grantor has agreed to secure such Grantor's obligations under the Credit Documents as set forth therein; and

WHEREAS, Assignees and Assignor entered into that certain Pledge and Security Agreement, dated as of May 9, 2008 (the "Security Agreement");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on April 15, 2004, at Reel 2833/Frame 0218;

WHEREAS, each Assignee has paid all of such Assignee's outstanding indebtedness to Assignor concerning the Intellectual Property Collateral (as defined below);

WHEREAS, pursuant to the Security Agreement, each Assignee granted to Assignor a security interest in and continuing lien on all of such Assignee's right, title and interest in, to and under all personal property of such Assignee including, but not limited to the following, in each case whether then owned or existing or thereafter acquired and arising and wherever located (collectively, the "Intellectual Property Collateral");

(a) all Intellectual Property, including but not limited to all Trademarks, and all registrations and applications set forth on Schedule I hereto;

(b) to the extent not otherwise included above, all Proceeds, products, accessions, rents and profits of or in respect of any of the foregoing.

WHEREAS, Assignor and Assignees desire that Assignor terminate and release its security interest in all of each Assignee's right, title and interest in and to the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby releases and discharges its continuing security interest in all of each Assignee's rights, title and interest in, to and under the Intellectual Property Collateral, including but not limited to all Trademarks and the registrations and applications set forth on Schedule I hereto, and reassigns and transfers any and all rights, title and interest that Assignor may have in the Intellectual Property Collateral, Trademarks, and the registrations and applications set forth on Schedule I hereto to Assignee.

Assignor hereby authorizes Assignees or Assignees' authorized representative to (i) file this Release with the United States Patent and Trademark Office, (ii) file Form UCC-3 Termination Statements or such other forms as may be necessary or appropriate to memorialize the release of any security interest of Assignor in the Intellectual Property Collateral, Trademarks, and the registrations and applications set forth on Schedule I hereto, and/or (iii) otherwise file this Release in the applicable governmental office or agency.


Assignor shall, at Assignees' expense, take all further actions, and provide to Assignees, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Assignees to more fully and effectively effectuate the purposes of this Release.
