**RELEASE AND TERMINATION OF SECOND LIEN SECURITY INTERESTS IN
TRADEMARKS**

THIS RELEASE AND TERMINATION OF SECOND LIEN SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of June 8, 2011 and granted by Citicorp North America, Inc., in its capacity as administrative agent and collateral agent (in such capacity, the "Agent") pursuant to (1) the Second Trademark Lien Security Agreement dated as of March 31, 2006 between Quintiles Transnational Corp. ("QNC") and the Agent and (2) certain amendments to and supplementations of the Security Agreement in 2009, 2010, and 2011 by and among QNC, Agent, and certain other grantor parties (all such grantor parties together with QNC, collectively, "Pledgors") (the Security Agreement and all such amendments and supplementations, collectively, the "Security Agreements"), in favor of the Pledgors. Capitalized terms used but not otherwise defined herein have the meanings set forth in the Security Agreements.

WHEREAS, pursuant to the terms and conditions of the Security Agreements, the Pledgors granted to the Agent a continuing lien on and security interest in and to all of its right, title and interest in, to and under the Trademarks set forth on Schedule I hereto (collectively, the "Trademark Collateral"),

WHEREAS the Trademark Security Agreements have been recorded with the Assignment Division of the U.S. Patent and Trademark Office as follows: (1) on April 4, 2006 at Reel 3282 and Frame 0260; (2) on April 21, 2009 at Reel 3973 and Frame 0254; (3) on March 30, 2010 at Reel 4176 and Frame 0085; and (4) on April 18, 2011 at Reel 4523 and Frame 0579; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, cancels, re-pledges, reassigns and releases to the Pledgors any and all liens and security interests it has against the Trademark Collateral.

If and to the extent the Agent has acquired any right, title or interest to, or any goodwill connected with the use thereof and symbolized thereby, any of the Trademark Collateral, it hereby irrevocably and unconditionally assigns and transfers such rights, title or interest and goodwill to the respective Pledgors, including, but not limited to, any and all rights to sue for and collect damages for past infringements.

Agent hereby authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release. This Release shall be construed in accordance with and governed by the law of the State of New York.
