RELEASE

This Release, dated as of November 29, 2007 (the "Release"), is made by Lehman Commercial Paper Inc., as collateral agent (in such capacity, the "Collateral Agent"), pursuant to the termination of that certain Credit Agreement, dated as of July 29, 2005 (as amended, supplemented, replaced or otherwise modified from time to time, the "Credit Agreement"), by and among Key Energy Services, Inc., the several banks and other financial institutions or entities from time to time parties thereto, Lehman Brothers Inc. as advisor, lead arranger and bookrunner, Wells Fargo Foothill, Inc. as Revolving Administrative Agent, and Lehman Commercial Paper Inc., as Administrative Agent, Collateral Agent and Syndication Agent. All capitalized terms used herein that are defined in IP Agreement (as defined below), and that are not otherwise defined herein shall have the respective meanings ascribed thereto in the Credit Agreement.

WITNESSETH

WHEREAS, pursuant to the Intellectual Property Security Agreement, dated July 29, 2005 and recorded with the United States Patent and Trademark Office on August 22, 2005 at Reel/Frame Number 16427/0646, with respect to the patents and on August 24, 2005 at Reel/Frame Number 3146/0596, with respect to the trademarks (the "IP Agreement"), the Grantors granted the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in all of such Grantor's right, title and interest in and to certain Intellectual Property Collateral;

WHEREAS, the Collateral Agent acknowledges that full payment, complete performance and satisfaction of all obligations pursuant to the Credit Agreement secured by the IP Agreement have been made; and

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in the Intellectual Property Collateral in connection with the termination of the Credit Agreement and the IP Agreement;


NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby releases, without recourse, all of its security interest in the Intellectual Property Collateral, listed on Schedule 1 attached hereto (the "Released Collateral") and incorporated herein by reference, and any other Intellectual Property Collateral under, and as defined in, the Loan Documents (as defined in the Credit Agreement).

The Collateral Agent agrees to provide the Grantors with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.


