TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT, dated as of June 8, 2011, (this "Agreement") is made by each of the entities listed on the signature pages hereof as "Grantors" (each a "Grantor" and, collectively, the "Grantors"), in favor of GB Merchant Partners, LLC ("GB"), as administrative agent (in such capacity, together with its successors and permitted assigns, the "Administrative Agent") for the Secured Parties (as defined in the Credit Agreement referred to below).

WITNESSETH:

WHEREAS, pursuant to that certain Amended and Restated Term Loan and Security Agreement, dated as of even date herewith (as the same may be amended, amended and restated, supplemented or otherwise modified and in effect from time to time, the "Loan Agreement"), by, among others, Mayor's Jewelers, Inc., a Delaware corporation (the "US Borrower"), Birks & Mayors Inc., a Canadian corporation (the "Canadian Borrower" and, together with the US Borrower, collectively, the "Borrowers" and each individually, a "Borrower"), each Subsidiary of the Borrowers from time to time party thereto as a Guarantor, each Lender from time to time party thereto, GB, as the Administrative Agent, and GB and Wells Fargo Credit, Inc., as Co-Collateral Agents, the Lenders have severally agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, in order to secure the Obligations, each Grantor has, pursuant to the Trademark Collateral Security and Pledge Agreement, dated as of December 17, 2008 (as amended, amended and restated, supplemented or otherwise modified and in effect from time to time, the "Trademark Agreement"), granted a security interest in the Pledged Trademarks in favor of the Administrative Agent for the benefit of the Secured Parties;

NOW, THEREFORE, in consideration of the premises and to induce the Lenders, and the Administrative Agent to enter into the Loan Agreement and to induce the Lenders to make their respective extensions of credit to the Borrowers thereunder, each Grantor hereby agrees with the Administrative Agent as follows:

Section 1. Defined Terms. Capitalized terms used herein (including above) without definition are used as defined in the Trademark Agreement.

Section 2. Grant of Security Interest in Trademark Collateral. Each Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations, hereby unconditionally grants to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in and first priority lien on all of such Grantor's right, title and interest in and to all of the Trademarks set forth on Schedule 1 hereto (together with the Trademark Registrations, Trademark License Rights, Trademark Rights, Associated Goodwill, Related Assets and all accessions to, substitutions for, replacements of, and all

products and proceeds of any and all of the foregoing, in each case, relating to such Trademarks, the "Trademark Collateral").

Section 3. Loan Agreement and Trademark Agreement. The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Administrative Agent pursuant to the Loan Agreement and Trademark Agreement and each Grantor hereby acknowledges and agrees that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Loan Agreement and Trademark Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

Section 4. Grantor Remains Liable. Each Grantor hereby agrees that, anything herein to the contrary notwithstanding, such Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary actions in connection with the Trademark Collateral.

Section 5. Counterparts. This Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart. Delivery of an executed signature page of this agreement by facsimile transmission or by other electronic transmission shall be as effective as delivery of a manually executed counterpart hereof.

Section 6. Governing Law. THIS AGREEMENT AND THE OBLIGATIONS OF THE PARTIES HERETO SHALL FOR ALL PURPOSES BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK (EXCLUDING THE LAWS APPLICABLE TO CONFLICTS OR CHOICE OF LAW (OTHER THAN THE NEW YORK GENERAL OBLIGATIONS LAW §§5-1401 AND 5-1402)).
