INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT

This INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT (this "*IP Security Release*") dated June 1, 2011, is made by BANK OF AMERICA, N.A., as administrative agent (the "*Administrative Agent*") for each of the Secured Parties (as defined in the Credit Agreement referred to below), in favor of INFORMATION RESOURCES, INC. (the "*Borrower*"), INFORMATION RESOURCES DHC, INC., INFOSCAN ITALY HOLDINGS, INC., IRI BWS HOLDINGS, INC., IRI CYPRUS HOLDINGS, INC., IRI FRENCH HOLDINGS, INC., IRI GREEK HOLDINGS, INC., IRI GUATEMALA HOLDINGS, INC., IRI ITALY HOLDINGS, INC., IRI LOGISTICS, INC., NORTH CLINTON CORPORATION, SHOPPERS HOTLINE, INC., 564 RANDOLPH CO. #2, (together with the Borrower, collectively, the "*Grantors*" and each a "*Grantor*"). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Credit Agreement or the IP Security Agreement, as applicable (each as defined below).

WHEREAS, the Secured Parties agreed to provide to the Borrower certain credit facilities, including a revolving credit facility with a letter of credit sublimit pursuant to a certain Credit Agreement dated as of May 16, 2007, between the Borrower, the Lenders party thereto, and the Administrative Agent (as from time to time amended, revised, modified, supplemented or amended and restated, the "*Credit Agreement*");

WHEREAS, pursuant to the Credit Agreement and that certain Intellectual Property Security Agreement dated as of May 16, 2007, between the Grantors and the Administrative Agent (the "*IP Security Agreement*"), the Grantors granted to the Administrative Agent for the benefit of the Secured Parties a continuing security interest in and to certain intellectual property of the Grantors;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on July 19, 2007 at Reel 019628 and Frame 0316 with respect to United States patents and patent applications, on July 24, 2007 at Reel 3587 and Frame 0964 with respect to United States trademark registrations and applications, and with the United States Copyright Office on October 16, 2007 in Volume 3555 and Document No. 017 with respect to United States copyrights; and

WHEREAS, the Grantors have satisfactorily paid all of their obligations under the Credit Agreement and the Administrative Agent, on behalf of the Secured Parties, now desires to release in its entirety its security interest in, to and under the Collateral, including the Patents, Trademarks and Copyrights identified on Schedules I, II, and III attached hereto (collectively, the "*Released Collateral*").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent agrees as follows:

SECTION 1. Release of Security Interest. The Administrative Agent, on behalf of the Secured Parties, hereby terminates and releases to the Grantors in its entirety all right, title and interest in and to (including any lien on and/or security interest in) the Released Collateral, and all right, title and interest of the Administrative Agent (or the Secured Parties) in and to the

Released Collateral are hereby assigned by the Administrative Agent, on behalf of the Secured Parties, to the Grantors.


SECTION 2. Recordation. The Administrative Agent authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this IP Security Release. The Administrative Agent shall provide the Grantors, their successors and assigns, or their legal representatives, at the Grantors' expense, such information and assistance as the Grantors may reasonably request (including, without limitation, execution and delivery of any documents as may be reasonably required) in connection with filing the appropriate documentation with the appropriate authority to perfect the release of the security interest on the Released Collateral.

SECTION 3. Governing Law. This IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.
