## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** (this "Assignment") is made and entered into as of this 28<sup>th</sup> day of June, 2009 ("Effective Date"), by and among Gabriel Ride Control Products, Inc. ("GRCP"), a Delaware corporation, and ArvinMeritor Canada, an Ontario partnership, Arvin Ride Control Products, Inc., an Ontario corporation, ArvinMeritor Technology, LLC, a Delaware limited liability company, ArvinMeritor, Inc., an Indiana corporation, Arvin Technologies, Inc., a Michigan corporation and Maremont Corporation, a Delaware corporation (collectively, "Seller Affiliates," and together with GRCP collectively referred to herein as "Assignor") and Ride Control, LLC, a Delaware limited liability company ("Assignee").

**WHEREAS**, Seller Affiliates are affiliates of GRCP;

**WHEREAS**, GRCP and Assignee are parties to that certain Asset Purchase Agreement, dated as of June 28, 2009 (the "Agreement") and pursuant to the Agreement GRCP has agreed to transfer certain Trademarks to Assignee, and certain of said Trademarks are currently titled in the name of Seller Affiliates; and

**WHEREAS**, pursuant to the Agreement, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all domestic and foreign trademarks, including the goodwill associated therewith, and any other indicia of source used in the Acquired Business (as that term is defined in the Agreement) and set forth on Schedule A attached hereto, including all applications and registrations (collectively, the "Trademarks").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee its entire right, title and interest in and to the Trademarks, together with all the associated goodwill of its business symbolized thereby, as well as all rights to injunctive relief, damages and profits, due or accrued, arising out of all causes of action, past, present and future, including infringement or other unauthorized use of the Trademark, or other violations, or injury to the said goodwill, and the right to sue for and recover the same in Assignee's own name and the names of Assignee's successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties, damages or payments due or payable as of the Effective Date or thereafter.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as assignee and owner of the Trademarks.

Assignor shall without charge to, but at Assignee's expense, take all further actions, and provide to Assignee, Assignee's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, exhibits,

assignments, powers of attorney or other documentation), reasonably requested by Assignee to more fully and effectively effectuate the purposes of this Assignment, including, without limitation with respect to (1) the preparation and prosecution of any applications relating to the rights assigned herein; (2) the prosecution or defense of any interference, opposition, cancellation, or other proceedings that may arise in connection with any of the rights assigned herein, including, without limitation, testifying as to any facts relating to the Trademarks or this Assignment; (3) obtaining any additional trademark protection relating to the rights assigned herein that Assignee may deem appropriate which may be secured under the laws now or hereafter in effect in the United States or any foreign country; and (4) the implementation or perfection of this Agreement in all applicable jurisdictions throughout the world.

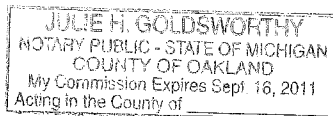

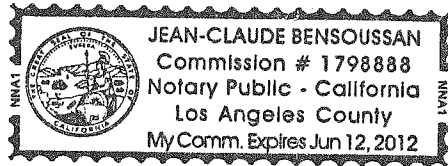
