**TERMINATION AND RELEASE OF TRADEMARK
COLLATERAL SECURITY AND PLEDGE AGREEMENT**

This Termination and Release of Trademark Collateral Security and Pledge Agreement (the "Release") is conveyed as of June 10, 2011, by BANK OF AMERICA, N.A., a national banking association, as administrative agent for itself and other Lenders (as defined below) under the Credit Agreement referred to below ("BofA"), in favor of CBC RESTAURANT CORP., a Delaware corporation ("CBC").

WHEREAS, pursuant to that certain Credit Agreement dated March 29, 2007 by and among CBC and Il Fornaio (America) Corporation, a Delaware corporation (collectively, the "Borrowers"), the lenders party thereto (collectively, the "Lenders") and BofA, as administrative agent (as amended, amended and restated, or otherwise modified to the date hereof, the "Credit Agreement"), CBC granted BofA a continuing security interest (the "Security Interest") in favor of BofA, in and to certain intellectual property held by CBC, including without limitation the trademark registrations and applications listed in Schedule A (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks.

WHEREAS notice of the Security Interest was recorded with the United States Patent and Trademark Office on April 2, 2007 at Reel 3512, Frame 0632.

WHEREAS CBC has fulfilled its obligations under the Credit Agreement, and BofA has therefore agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, BofA, for itself and on behalf of the Lenders, hereby releases all liens and the Security Interest, hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to CBC and its successors and assigns in association with the Security Interest, and hereby releases CBC and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
