I, Bill Trupkiewicz, hereby declare as follows:

1. I am the Secretary of JBS USA, LLC, a Delaware limited liability company and an affiliate of and authorized signatory for Skippack Creek Corporation, a Delaware corporation. I am making and submitting this Declaration for the purpose of removing the Trademark from the assignment recorded on April 16, 1975, at Reel/Frame 0265/0399 (the "Trademark Assignment Filing"). A copy of the Trademark Assignment Details for Reel/Frame 0265/0399, obtained from the Trademark Office website, is attached hereto as Exhibit 1.


2. The Trademark was erroneously included in the Trademark Assignment Filing. The last correct assignee of the Trademark on record at the Trademark Office, Skippack Creek Corporation, is, and continues to be, the correct owner of the Trademark. As evidenced by the assignment recorded on March 24, 1993 at Reel/Frame 0936/0162, the original registrant, Moyer Packing Company, assigned all of its interest in the Trademark to Skippack Creek Corporation.

3. There is no evidence recorded at the Trademark Office that the original registrant, Moyer Packing Company, assigned any interest in the Trademark to William McCurdy, who subsequently assigned his interest in the Trademark to V. T.

Finch d/b/a Classical Trim Company, as referenced in the Trademark Assignment Filing. I have attempted to contact the parties named in the Trademark Assignment Filing to correct the error, but to the best of my knowledge, such parties no longer exist.

4. I hereby respectfully request that the Commissioner for Trademarks and any other applicable government officer remove the Trademark from the assignment recorded at Reel/Frame 0265/0399 and record this Declaration.
