MERGING
SPECTORSOFT CORPORATION, A FLORIDA CORPORATION
WITH AND INTO
SPECTORSOFT CORPORATION, A DELAWARE CORPORATION**

**Pursuant to Section 607.1105 of the
Florida Business Corporation Act**

SpectroSoft Corporation, a Delaware corporation (the "Subsidiary"), does hereby certify the following facts relating to the merger (the "Merger") of SpectroSoft Corporation, a Florida corporation (the "Parent"), with and into the Subsidiary, with the Subsidiary continuing as the surviving corporation of the Merger (the "Surviving Corporation"):

- FIRST:** The name of the surviving corporation of the Merger shall be SpectroSoft Corporation. The Surviving Corporation shall be a Delaware corporation.
- SECOND:** The constituent merging corporations in the Merger are the Parent and the Subsidiary.
- THIRD:** The Agreement and Plan of Merger (the "Plan of Merger") is attached hereto as Exhibit A.
- FOURTH:** The Merger shall become effective immediately upon the later of the filing of these Articles of Merger with the Florida Department of State and the filing of a certificate of merger with the Secretary of State of the State of Delaware.
- FIFTH:** The Plan of Merger was adopted by the sole shareholder of the Subsidiary on August 13, 2008.
- SIXTH:** The Plan of Merger was adopted by the shareholders of the Parent on August 13, 2008.
- SEVENTH:** The signatures for each constituent corporation are on the following page.

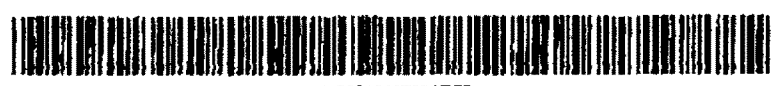
