RDA covenants that RDA is the owner of the Marks and the holder of record title to the

Registrations, that RDA has full power to make this Assignment and that RDA agrees to execute such further assignments and related documents with respect to the Marks, the Goodwill, and the Registrations as SABMD shall reasonably request.

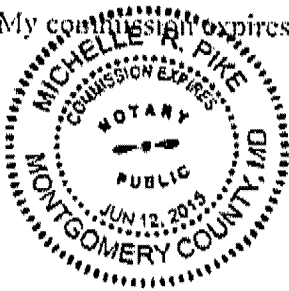
