RELEASE OF SECURITY INTEREST IN TRADEMARK

WHEREAS, on or about October 20, 2008, **PERFECT PUSHUP, LLC**, a California limited liability company ("Borrower"), executed an Intellectual Property Security Agreement dated October 10, 2008, as amended ("Agreement") in favor of **Comerica Bank** ("Secured Party") wherein Borrower granted Secured Party a security interest in certain intangible property, including but not limited to that Trademark set forth on Exhibit A attached hereto ("Trademark"), to induce Secured Party to lend Borrower certain funds; and

WHEREAS, in the Agreement, Borrower represented that it was the sole owner of the Trademark and authorized the Agreement to be recorded with the United States Patent and Trademark Office ("USPTO"); and

WHEREAS, pursuant to the terms of the Agreement, Secured Party filed the Agreement with the USPTO; and

WHEREAS, subsequent to the filing the Agreement with the USPTO, Secured Party discovered that Borrower does not have an interest in the Trademark, one or more other parties may own in the Trademark, and the Trademark was inadvertently included in the Agreement; and

WHEREAS, due to the inadvertent filing, Secured Party desires to release all of its all security interest in the Trademark.

NOW, THEREFORE, to the fullest extent permitted by law, Secured Party hereby releases and discharges all of Secured Party's security interests and liens on the Trademark of record with the USPTO, as more fully set forth on Exhibit A hereto.
