**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS** (the "*Termination and Release*"), dated as of June 13, 2011, is made by **AMP ADMIN LLC** (as successor agent to Emporia Capital Funding LLC), as Administrative Agent for the Lenders, (in such capacity, the "*Agent*"), in favor of **DIVING SCIENCE & TECHNOLOGY CORP.**, a California corporation, **PADI TRAVEL NETWORK, INC.**, a California corporation and **EMERGENCY FIRST RESPONSE CORP.**, a California corporation (collectively, the "*Grantor*").

WITNESSETH:

WHEREAS, Grantor and Agent are parties to (i) that certain Guarantor Security Agreement, dated as of July 27, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "*Security Agreement*") (all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Security Agreement, as applicable).

WHEREAS, pursuant to the terms and conditions of the Security Agreement, the Grantor granted to the Agent a continuing security interest in all of its right, title and interest in and to certain collateral, including without limitation the trademark registrations and trademark applications set forth on Schedule A hereto, together with the goodwill associated therewith (collectively, the "*Trademark Collateral*");

WHEREAS, the Security Agreement was recorded with U.S. Patent & Trademark Office on August 31, 2007 at Reel 3613 and Frame 0091; and


WHEREAS, the Agent now desires to terminate and release its security interest in and liens upon the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- (a) the Agent hereby terminates, reassigns, releases and discharges any and all security interests and liens it has in the Trademark Collateral;
- (b) if and to the extent that the Agent has acquired any right, title or interest to any of the Trademark Collateral, it hereby assigns and transfers such rights, title or interest to the Grantor; and
- (c) the Agent shall take all further actions, and provide to the Grantor and each of its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments reasonably requested by the Grantor) as may be reasonably necessary to more fully and effectively effectuate the purposes of this Termination and Release, in each case at the expense of the Grantor.


