THIS ASSIGNMENT is made on this 7th day of December, 2010;

BETWEEN:

1. **US NONWOVENS CORPORATION**, a corporation organized and existing under the laws of the state of New York, with a business address of 100 Emjay Boulevard, Brentwood, New York 11717 ("Assignor"); and
2. **THE SUN PRODUCTS CORPORATION**, a corporation organized and existing under the law of the state of Delaware, with a business address of 60 Danbury Road, Wilton, Connecticut 06897 ("Assignee").

RECITALS:

- (A) **WHEREAS**, Assignor is the owner of all right, title, and interest in and to the trademarks set out in the Schedule attached hereto (the "Trademarks") in the United States;
- (B) **WHEREAS**, Assignee is desirous of obtaining Assignor's right, title, and interest in and to the Trademarks; and
- (C) **WHEREAS**, Assignor, itself or through its parent or affiliated companies, in settlement of a suit commenced by Assignee in the U.S. District Court for the District of Delaware and having Case No. C.A. No. 1:10-cv-00438-JJF, has agreed to assign, transfer, convey, and deliver its entire right, title, and interest in and to the Trademarks pursuant to the terms of a Confidential Settlement Agreement dated December 6, 2010, (the "Settlement Agreement") among Assignor, Assignee *et al.*

NOW IT IS HEREBY AGREED AS FOLLOWS:

1. **Assignment**

In consideration of the premises contained in this Assignment and in the Parties' Settlement Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby transfers, assigns, conveys, and delivers to Assignee, its successors and assigns, all right, title, and interest in and to the Trademarks together with any and all goodwill associated therewith, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, together

with the rights of recovery, rights of set-off, rights of compensation, claims and causes of action, and all other corresponding rights, and all rights of actions, powers, and benefits either belonging to the same or accrued.

2. Counterparts

This Assignment may be executed in counterparts and by the parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but the counterparts together shall constitute one and the same Assignment.

3. Governing Law

This Assignment shall be governed by and interpreted in accordance with the laws of the state of Delaware.
