RELEASE OF SECURITY INTERESTS IN TRADEMARKS

WHEREAS, pursuant to a General Security Agreement dated April 12, 2011 between, Forgitron Technologies, LLC. 3. The Lender hereby authorizes Borrower to record this Release of Security Interests in Trademarks with the PTO and hereby authorizes, and requests, the Director of the PTO or his delegate to record this Release of Security Interests in Patents.
