This Memorandum of Security Agreement has been executed on behalf of NNPI as of March 31, 2011.

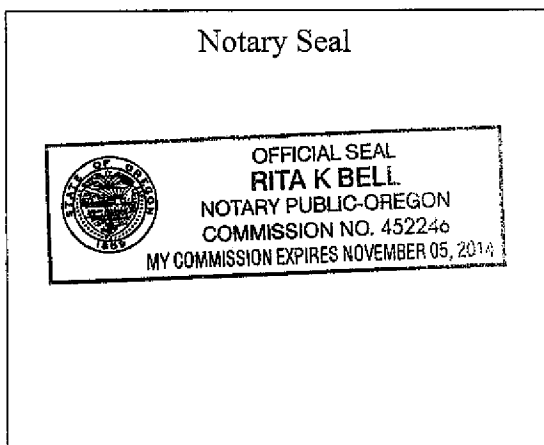
