Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act, the undersigned foreign corporation has executed the following Certificate of Merger:

FIRST: The name of the surviving business entity is SDI, Inc. (“Surviving Corporation”).

SECOND: The jurisdiction in which the Surviving Corporation was formed is Pennsylvania.
