RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release"), is granted and conveyed as of this 20 day of June, 2011, by Wells Fargo Capital Finance, Inc., as agent for the Lender Group and the Bank Product Providers (as defined in the Security Agreement) ("Agent"), in favor of Wall Street Systems Treasury, Inc., a Delaware corporation ("Obligor").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of January 31, 2011, by and between Obligor and Agent (the "Security Agreement"), Obligor has granted a security interest in certain of its tangible and intangible property, including, but not limited to, the trademarks listed on the attached Schedule A and the registrations and applications thereof and other Trademark Collateral (as defined in the Security Agreement) (collectively, the "Released Trademarks");

WHEREAS, the Security Agreement was recorded on behalf of Agent in the United States Patent and Trademark Office, on March 11, 2011 at reel/frame 4497/0123, to evidence the security interest granted to Agent thereunder;

WHEREAS, Obligor has requested that Agent: (a) terminate and release the liens and interests of Agent in the Released Trademarks; and (b) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office and any similar office or agency anywhere in the world, including without limitation the Canadian Intellectual Property Office; and

WHEREAS, Obligor has satisfied and fulfilled all of their obligations to release the Agent's security interest in the Released Trademarks under the Security Agreement, and the parties seek to make a record of Agent's release and reassignments to Obligor of any and all of its security interests in the Released Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby unconditionally, irrevocably and absolutely releases, discharges, and relinquishes its security interests in the Released Trademarks and hereby unconditionally, irrevocably and absolutely assigns, transfers and conveys to Obligor any and all right, title and interest of Agent in, to and under the Released Trademarks. Agent specifically acknowledges that its security interests in the Released Trademarks are no longer in force. This Release shall be binding upon Agent's legal representatives, assigns and successors and upon the Lender Group and the Bank Product Providers. Agent agrees that this Release may be recorded by or for Obligor with the United States Patent and Trademark Office and any similar office or agency anywhere in the world, including without limitation the Canadian Intellectual Property Office.
