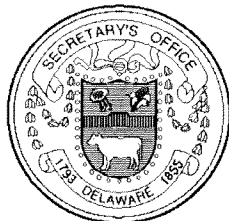

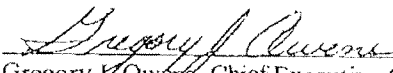
The undersigned, Gregory J. Owens and John V. Bautista, hereby certify that:

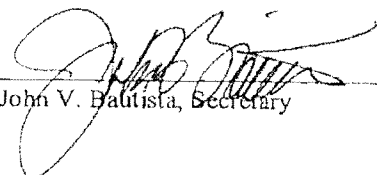
"The name of the corporation is IronPlanet, Inc. (the "Corporation")."
