**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "**Release**"), dated as of June 20, 2011, is made by JPMorgan Chase Bank, N.A., as administrative agent (the "**Agent**"), under the Security Agreement (as defined below).

WHEREAS, Precision Valve Corporation (the "**Company**") is a party to that certain Amended and Restated Security Agreement, dated as of August 26, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreement**"), made by the Company and the other grantors named therein in favor of the Agent; and

WHEREAS, pursuant to the Security Agreement and that certain Security Agreement (Trademarks) dated as of August 26, 2010 (the "**Trademark Security Agreement**") made by the Company in favor of the Agent, the Company granted to the Agent a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks and trademark applications listed on Annex I attached hereto; and


WHEREAS, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on August 27, 2010, on Reel/Frame 004268/0076.

NOW THEREFORE, the Agent hereby releases, without representation, recourse or warranty whatsoever, its security interest in the Trademark Collateral granted pursuant to the Security Agreement or the Trademark Security Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Trademark Collateral to the Company.

The Agent agrees, at the Company's expense, to cooperate with the Company to provide the Company with any additional information or authorization reasonably required or desirable to effect the release of the Agent's security interest in the Trademark Collateral.
