That the Secured Party's claim, right, title or interest in and to any and all of the Collateral that arose from the Amended and Restated Loan Agreement of March 7, 2011, the Security Agreement of March 7, 2011, and all other prior agreements between the Debtor and the Secured Party, including, but not limited to the items identified in the EXHIBIT hereto, are hereby released.

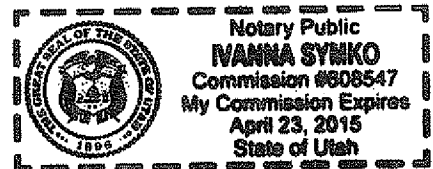
