1. Assignor does hereby sell, assign, convey, transfer and deliver to Assignee, all rights, title and interest it has in and to the Service Mark.


All agreements and stipulations herein shall inure to the benefit of and be binding upon the heirs, successors and assigns of the respective parties hereto.
