RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of February 23, 2011 (this "Release"), by WELLS FARGO BANK, NATIONAL ASSOCIATION ("Secured Party").

WHEREAS, pursuant to the Security Agreement (the "Pensa Security Agreement"), dated as of November 5, 1981, made by Pensa, Inc. dba AVIA ("Pensa") in favor of the First National Bank of Oregon ("FNB Oregon"), Pensa granted a security interest (the "FNB Oregon Security Interest") in the trademarks listed therein to FNB Oregon and, in connection therewith, the Pensa Security Agreement was recorded in the United States Patent and Trademark Office ("USPTO") at Reel/Frame 0404/0454;

WHEREAS, pursuant to the Memorandum of Security Agreement (the "Ryka Security Agreement"), dated as of August 14, 1996, made by Ryka Inc. ("Ryka") in favor of CoreStates Bank, N.A. ("CoreStates"), Ryka granted a security interest (the "CoreStates-Ryka Security Interest") in the trademarks listed therein to CoreStates and, in connection therewith, the Ryka Security Agreement was recorded in the USPTO at Reel/Frame 1496/0801;

WHEREAS, pursuant to the Memorandum of Security Agreement (the "KPR Security Agreement"), dated as of August 15, 1996, between KPR Sports International ("KPR") and CoreStates, KPR granted a security interest (the "CoreStates-KPR Security Interest") in the trademarks listed therein to CoreStates and, in connection therewith, and the KPR Security Agreement was recorded in the USPTO at Reel/Frame 1530/0774;

WHEREAS, pursuant to the Memorandum of Security Agreement (the "Apex Security Agreement"), dated as of August 15, 1996, between Apex Sports International, Inc. ("Apex") and CoreStates, Apex granted a security interest (the "CoreStates-Apex Security Interest") and, together with the FNB Oregon Security Interest, the CoreStates-Ryka Security Interest and the CoreStates-KPR Security Interest, the "Security Interests") in the trademarks listed therein to CoreStates and, in connection therewith, the Apex Security Agreement was recorded in the USPTO at Reel/Frame 1496/0803;

WHEREAS, pursuant to the Bill of Sale and Assignment, dated as of December 29, 1999 by Ryka, KPR, G.S.I., Inc. and Apex (collectively, the "Seller") in favor of American Sporting Goods Corporation (the "Grantor"), the Seller sold, transferred, assigned conveyed and delivered to the Grantor all of Seller's right, title and interest in and to certain trademarks subject to the CoreStates-Ryka Security Interest, the CoreStates-KPR Security Interest or the CoreStates-Apex Security Interest;

WHEREAS, pursuant to the Asset Purchase Agreement, dated as of May 31, 1996 among the Grantor, Avia Group International, Inc. ("Avia") and Reebok International Ltd. ("Reebok"), the Grantor purchased certain trademarks subject to the Pensa Security Agreement;

WHEREAS, effective June 1, 1981 FNB Oregon changed its name to First Interstate Bank of Oregon, National Association and effective June 1, 1996 First Interstate Bank of

WHEREAS, effective May 15, 1998 CoreStates merged with and into First Union National Bank, and effective April 1, 2002 Wachovia Bank, National Association merged with and into First Union National Bank, with the resulting title of Wachovia Bank, National Association ("Wachovia"), and effective March 20, 2010, Wachovia merged with and into the Secured Party with the resulting title of Wells Fargo Bank, National Association;

WHEREAS, the Grantor has advised the Secured Party and the Secured Party has confirmed that all indebtedness and other obligations secured by the Security Interests has been paid in full and the Security Interests have terminated and been released; however, the Security Interests as recorded in the USPTO have not been released of record; and

WHEREAS, the Grantor has requested the Secured Party to execute this Release of the Security Interest in the Released Collateral (as hereinafter defined) and the Secured Party is willing to do so.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, in accordance with the terms of the Guarantee and Collateral Agreement and the Security Agreement, the parties hereto hereby agrees as follows:

1. Released Collateral. The term "Released Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature in and to (a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, in each case listed on Schedule I, all registrations and recordings thereof, and all registration and recording applications filed in the United States Patent and Trademark Office and all extensions or renewals thereof (the "Released Trademarks"); (b) all goodwill associated with or symbolized by the Released Trademarks; (c) all assets, rights and interests that uniquely reflect or embody the Released Trademarks; and (d) all property described in the Panna Security Agreement.
2. Release. The Secured Party hereby releases the Security Interest in the Released Collateral.
3. Recordation. The Secured Party hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States to record this release of the Security Interest in the Released Collateral.
4. Modification. This Release may not be modified, nor may any provision hereof be waived, orally or in any manner other than by an agreement in writing signed by the undersigned with the consent of the Grantor or their respective successors and assigns.
