

**ARTICLES OF AMENDMENT
OF THE ARTICLES OF INCORPORATION
OF
NEXIUS, INC.**

Nexius, Inc., a corporation organized and existing under and by virtue of the Virginia Stock Corporation Act (the "*Corporation*"), does hereby certify that:

FIRST: The name of the Corporation prior to amendment is Nexius, Inc.

SECOND: The sole Shareholder and the Board of Directors of the Corporation have deemed it advisable and in the best interests of the Corporation to adopt the following amendment to the Articles of Incorporation of the Corporation to change the name of the Corporation:

Article 1 of the Articles of Incorporation of the Corporation shall be deleted in its entirety and replaced as follows:

"FIRST: The undersigned, the name of the corporation (hereinafter called the "*Corporation*") is: CSWS, Inc."

THIRD: The foregoing amendment was duly adopted in accordance with the provisions of Section 13.1-710 of the Virginia Stock Corporation Act by written consent of the sole Shareholder and unanimous written consent of the Board of Directors, each dated July 6, 2010.

FOURTH: That these Articles of Amendment of the Articles of Incorporation shall be effective immediately.

FIFTH: The remaining provisions of the Corporation's Articles of Incorporation shall continue in full force and effect.


