## RELEASE OF TRADEMARKS

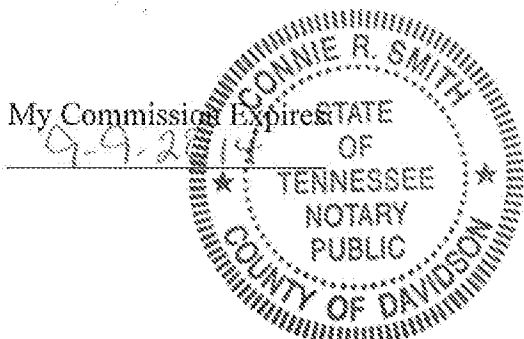
