GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS

As of June 14, 2011

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, MEARTHANE PRODUCTS CORPORATION, a Rhode Island Corporation, (the "Grantor") with its principal executive offices at 16 Western Industrial Drive, Cranston, Rhode Island 02921, hereby grants to BANK OF AMERICA, N.A., successor by merger with Fleet National Bank, a national banking association (the "Bank") with an address at One Federal Street, Boston, Massachusetts 02110 (the "Grantee"), a continuing security interest in (i) all of such Grantor's right, title and interest in, to and under the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT ("Grant") is made to secure the satisfactory performance and payment of all present and future "Obligations" of the Grantor to the Grantee, as such quoted term is defined and otherwise described in that certain Forbearance and Amendment Agreement dated as of April 1, 2011 between, among others, the Grantor and the Grantee (the "Agreement") and, without limitation, as further described and otherwise set forth in the following documents: (i) that certain Security Agreement dated as of August 11, 2004 (the "Security Agreement"); and (ii) that certain Trademark Collateral Assignment and that certain Trademark Mortgage, each in favor of the Fleet National Bank and each dated as of September 20, 2004 (singly and collectively, the "Existing Trademark Security Documents"), recorded with the United States Patent and Trademark Office, respecting all "Trademarks" (as defined and otherwise described in the Existing Trademark Security Documents) (as each of the Security Agreement and the Existing Trademark Security Documents heretofore has been amended and as each may hereafter be amended, modified, restated, and/or supplemented from time to time, singly and collectively, the "Specified Security Documents"). As used herein, the term "Marks" also includes, without limitation, the definition of "Trademarks" included in the Existing Trademark Security Documents.

The Grantor authorizes the Grantee to modify the Grant herein without obtaining such Grantor's signature to such modification, to the extent that such modification constitutes an amendment of Schedule

A hereto, to add any right, title or interest in any Mark owned or subsequently acquired by Grantor or to delete any reference to any right, title or interest in any Mark in which Grantor no longer has or claims any right, title or interest. Grantor additionally agrees to execute any additional agreement or amendment hereto as Grantee reasonably requires from time to time, to subject any such owned or subsequently acquired right, title or interest in any Mark to the security interests and perfection created or contemplated hereby and/or by the Specified Security Documents.

This Grant has been granted in conjunction with, and is supplemental to, the security interests and assignments granted to the Grantee under the Specified Security Documents. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Agreement and the Specified Security Documents, all provisions, terms, and conditions of which are specifically incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Specified Security Documents, the provisions of the Specified Security Documents shall govern, subject at all times to the provisions, terms, and conditions of the Agreement. Nothing herein shall be deemed or otherwise construed to modify, amend, waive, limit, replace, or suspend the provisions, terms, conditions, rights, or remedies of the Grantee pursuant to the Agreement and/or the Specified Security Documents.

This Grant shall take effect as a sealed instrument and shall be construed, governed, and enforced pursuant to the law of the Commonwealth of Massachusetts and applicable federal law.
