TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of June 3, 2011 by GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware corporation, as administrative agent ("Agent").

. W I T N E S S E T H :

WHEREAS, Agent and NEXDSS, INC., a Georgia corporation ("Grantor"), were parties to that certain Trademark Security Agreement dated as of December 15, 2010 (the "Assignment"), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the "Trademarks") and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the United States Patent and Trademark Office on December 20, 2010 at Reel 004436, Frame 0686; and

WHEREAS, Grantor has requested that Agent release its security interest in and lien on the Trademarks and Trademark Collateral. Capitalized terms used herein without definition are used as defined in the Assignment.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases and discharges fully its security interest in and lien on all of Grantor's right, title and interest in and to the following (collectively, the "Trademark Collateral"):

(i) all of its Trademarks and all IP Licenses (as defined in the Credit Agreement dated as of December 15, 2010 among the Grantor and certain of its affiliates as borrowers and guarantors, and Agent) providing for the grant by or to such Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule 1 hereto;

(ii) all renewals and extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademark Collateral, if any.
