RELEASE OF SECURITY INTEREST IN TRADEMARK

This Release of Security Interest in Trademark (this "Release"), dated as of June 23, 2011, is executed by Deutsche Bank Trust Company Americas, formerly known as Bankers Trust Company ("Secured Party"), in favor of Ampac Fine Chemicals LLC ("Ampac").

RECITALS

WHEREAS, Secured Party and GENCORP INC. (the "Company") entered into an Amended and Restated Credit Agreement, dated as of October 2, 2002, which amended and restated the Credit Agreement, dated as of December 28, 2000 (as amended, the "Credit Agreement"), which Credit Agreement provided for, among other things, Secured Party and the other lenders (the "Lenders") party thereto, to, from time to time, extend credit to or for the account of Company;

WHEREAS, AEROJET-GENERAL CORPORATION ("Guarantor") guaranteed the obligations of the Company under the Credit Agreement and granted to the Lenders a security interest in Guarantor's assets, including, without limitation, the patents and trademarks of Guarantor;

WHEREAS, in connection with the Credit Agreement, Guarantor and Secured Party entered into a certain Patent and Trademark Security Agreement (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Guarantor granted to Secured Party a security interest in certain "Collateral", including the trademark listed on Exhibit A hereto (the "Trademark"); and


WHEREAS, the Credit Agreement and the Security Agreement have been terminated and the Secured Party's security interests have been released;

NOW, THEREFORE, Secured Party agrees as follows:

1. Secured Party is executing and delivering this Release as further evidence of the termination of the Security Agreement.
2. Secured Party claims no right, title or interest whatsoever in or to any of the "Collateral" described in the Security Agreement, and, accordingly, Secured Party expressly terminates its security interest in the Trademark, which security interest was evidenced by the recordation of the Security Agreement with the United States Patent and Trademark Office on January 10, 2001, in Reel/Frame 2224/0711.


