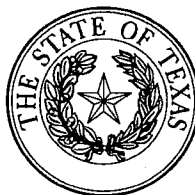

**Article 1 –Name**


