ASSIGNMENT OF TRADEMARK RIGHTS (United States)

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:



The Assignor hereby transfers, sells, conveys, assigns and delivers to the Assignee, and the Assignee hereby purchases, acquires, accepts and assumes, the Assignor's entire right, title and interest in, to and under the Assigned Marks, together with all common law trademark rights and the goodwill of the business symbolized by the Assigned Marks, as well as any and all claims, demands, causes of action, rights of opposition and cancellation, rights to sue or other rights occasioned from or because of any and all past or present infringement, dilution, or misappropriation of the Assigned Marks, and the right to collect damages therefor and all income, royalties, or payments due as of the Effective Date or hereafter.

2. Further Acts. From time to time, and when requested by the Assignee, the Assignor shall execute and deliver, or cause to be executed and delivered, all such documents and instruments and shall take, or cause to be taken, all such further or other actions as the Assignee may reasonably request to consummate and record this Assignment, including promptly executing and delivering to the Assignee such assignments and other instruments as the Assignee or its counsel may reasonably request as necessary or desirable for such purpose, at the Assignee's sole expense.


