THIS TRADEMARK ASSIGNMENT is dated as of September 30, 2010, between:

- (A) BECTON DICKINSON CRITICAL CARE SYSTEMS PTE. LTD., a Singapore Corporation, having its principal place of business at 198 Yishun Avenue 7, 768926, SINGAPORE (hereinafter "Assignor"); and

RECITALS

WHEREAS, Assignee is acquiring the portion of Assignor's business to which the Trademarks pertain.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee all right, title and interest to the Trademarks, including the goodwill associated with the Trademarks, together with all claims for damages that arise by reason of the Trademarks and the right to sue for and collect the same for its own use and benefit.
