This "Trademark Assignment" shall be binding upon and shall inure to the benefit of the respective successors and assigns of Assignor and Assignee.

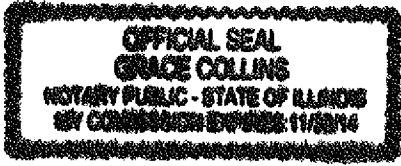
