TRADEMARK RELEASE

TRADEMARK RELEASE, effective as of this 1st day of July, 2011, given by Deutsche Bank Trust Company Americas, a New York banking corporation, as Collateral Agent (“Agent”) with principal offices at 60 Wall Street, New York, NY 10005, to GREEN TREE INVESTMENT HOLDINGS II LLC, a Delaware limited liability company (“Grantor”), with principal offices at 1100 Landmark Towers, 345 St. Peter Street, Saint Paul, MN 55102, as follows:

WHEREAS, the Grantor has heretofore granted to the Agent a security interest in certain United States trademarks, trademark registrations and trademark applications more particularly set forth on Schedule A attached hereto (the “Marks”) to secure the Obligations (as defined in that certain Security Agreement, dated as of December 18, 2009, between the Agent, the other assignors party thereto and the Grantor (the “Security Agreement”)); and

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Marks to the Grantor and to dissolve any and all liens and encumbrances respecting the Marks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Grantor the security interest in the Trademarks set forth on Schedule A granted to Agent by the Grantor pursuant to the Security Agreement, which security interest was duly recorded on December 22, 2009, at Reel 4118, Frame 0806 in the United States Patent and Trademark Office.


