TERMINATION OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

WHEREAS, ROBBINS BROS. JEWELRY, INC., a Delaware corporation (as successor in interest to Robbins Bros. Corporation (f/k/a William Pitt, LLC)) (the "Grantor"), had granted to WPC ENTREPRENEUR FUND II, L.P. (the "Secured Party"), a security interest (the "Security Interest") in the Grantor's trademarks and trademark applications (collectively, the "Trademarks") and the goodwill associated therewith, which was filed at the United States Patent and Trademark Office on December 28, 2004 and recorded on Reel 2998, Frame 0443;

WHEREAS, the indebtedness secured by the Security Interest has been paid in full and the Secured Party has agreed to terminate the Security Interest.


NOW, THEREFORE, the Secured Party releases and discharges its security interest in, and reassigns to the Grantor, any and all interest in the Trademarks, including, without limitation, those listed on Schedule A attached hereto, together with the goodwill associated therewith. The Secured Party agrees that, upon request of the Grantor or any successor-in-interest or assignee thereof, and at the Grantor's expense, the Secured Party will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Grantor, or any successor-in-interest or assignee thereof, to effectuate the release of interests contemplated herein.
