**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT is made as of the 16<sup>th</sup> day of May, 2011, by PNC BANK, NATIONAL ASSOCIATION (successor by merger to Mercantile-Safe Deposit And Trust Company), with its mailing address as 2 Hopkins Plaza, 5<sup>th</sup> Floor, Baltimore, Maryland 21201 ("LENDER") in favor of CP (DELAWARE), INC., a Delaware corporation, with its mailing address as 372 Rose Hill Road, West Grove, Pennsylvania 19390 ("ASSIGNOR").

**RECITALS**

Pursuant to the terms of a Trademark Security Agreement dated April 9, 2003 by ASSIGNOR in favor of the LENDER and recorded on April 23, 2003, with the United States Patent & Trademark Office in Reel 2716, Frame 0198 ("TRADEMARK AGREEMENT") ASSIGNOR granted to the LENDER a security interest in eight (8) Trademark Application/Serial Numbers and twenty-eight (28) Trademark Registration Nos., all as further described on Exhibit A attached hereto, and the goodwill of ASSIGNOR associated with such trademarks and certain other assets of ASSIGNOR described in the TRADEMARK AGREEMENT (collectively, "TRADEMARKS").

The LENDER has agreed to release all of its right, title, and interest in and to the TRADEMARKS.

1. **RELEASE**. The LENDER hereby releases its security interests and liens in and to the TRADEMARKS. In addition, the LENDER hereby agrees that the TRADEMARK AGREEMENT is terminated.

2. **BINDING NATURE**. This Release Of Trademark Security Agreement shall be binding upon the LENDER and its successors and assigns, and shall inure to the benefit of ASSIGNOR and their successors and assigns.



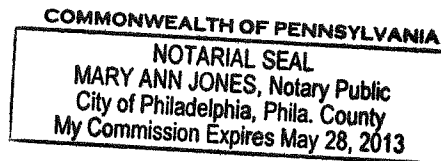
