

DECLARATION OF JOHN BENSON re TRADEMARK APPLICATION REQUEST NO. 77908777

I, John Benson, declare as follows:

I am the Chief Operating Officer of Verisys Corporation. I have been employed by the company since June 2007. I have personal and firsthand knowledge of the facts set forth herein, and if called to testify to these facts, I would and could do so competently under oath. This Declaration is provided in response to that Notice of Incomplete Extension Request issued on June 20, 2011 in connection with application serial number 77908777.

On January 11, 2010, I filed a request with the USPTO that a trademark be issued for "V AddressCheck." The applicant was Government Management Services, Inc. dba Verisys Corporation, a Virginia corporation. The name of the corporation was subsequently changed.

On February 4, 2010, Government Management Services, Inc. amended its Articles of Incorporation to change its name to Verisys Corporation. A Certificate of Amendment was issued by the Commonwealth of Virginia, State Corporation Commission on February 17, 2010, pursuant to which the name of the corporation was formally changed to Verisys Corporation. Attached hereto are true and correct copies of the Articles of Amendment, Certificate of Amendment, and Receipt of Payment.
