TERMINATION AND RELEASE OF SECURITY INTEREST

This **TERMINATION AND RELEASE OF SECURITY INTEREST**, dated as of June 29, 2011, is made by ACC Credit LLC (as successor agent to J.P. Morgan Chase Bank, N.A.) (the "Successor Agent"), as Administrative Agent.

WHEREAS, reference is hereby made to the Trademark Security Agreement (the "Agreement"), dated April 3, 2009 by and between American Civil Constructors Holdings, Inc., a Delaware corporation (the "Grantor"), and JPMorgan Chase Bank, N.A., as Administrative Agent (the "Agent"), whereby Grantor granted to the Agent a security interest in certain property, including a security interest in certain trademarks listed on Schedule A hereto (the "Trademarks");

WHEREAS, the Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on July 21, 2009 at Reel/Frame 4028/0256;

WHEREAS, the Agent assigned its security interest to the Trademarks to the Successor Agent on May 3, 2010, with such assignment recorded with the USPTO on June 28, 2010 at Reel/Frame 4233/0160; and


WHEREAS, the Successor Agent has agreed to terminate and release its security interest in all of such Trademarks as herein provided;
