ASSIGNMENT OF TRADEMARKS

Dated June 17, 2011

BE IT KNOWN BY THESE PRESENTS THAT:

WHEREAS, HEALTH RISK PARTNERS, LLC, a limited liability company formed under the laws of the Commonwealth of Virginia, having a principal place of business at 6802 Paragon Place, Suite 500, Richmond, Virginia 23230 (the "**Assignor**") owns the trademarks, service marks, tradenames, logos and trade dress set forth on **Schedule A** attached hereto (the "**Marks**"); and

WHEREAS, D2HAWKEYE, INC., a corporation organized under the laws of the State of Delaware, having a place of business at 545 Washington Boulevard, Jersey City, New Jersey 07310-1686 (the "**Assignee**") is desirous of acquiring all of the Assignor's right, title and interest in and to the Marks and any registrations and applications therefor in the United States and foreign countries, together with all of the goodwill of the business associated with the use of and symbolized by the Marks;

NOW, THEREFORE, in consideration of the Purchase Price and for other good and valuable consideration as more particularly described in an Asset Purchase Agreement, dated June 1, 2011 (the "**Purchase Agreement**"), entered into, *inter alia*, by the Assignor and the Assignee (none of the provisions of which shall be deemed to be modified, limited or amended hereby), the receipt and sufficiency of which the Assignor hereby acknowledges, the Assignor does hereby sell, assign and transfer unto the Assignee, its successors and assigns, its entire right, title and interest in and to (i) the Marks together with the goodwill of the business associated therewith, and any United States and foreign registrations and applications therefor and (ii) all rights of Assignor with respect to all other tradenames, trademarks, service marks, logos and trade dress used in connection with the business, together with all of the Assignor's goodwill of the business associated with the use of and symbolized by the foregoing along with all claims for damages by reason of past, present, and future infringement of the rights assigned under this Assignment, with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns, and other legal representatives, as fully and entirely as if the same would have been held and enjoyed by the Assignor if this transfer to the Assignee had not been made;

AND the Assignor, for the considerations aforesaid, hereby covenants and agrees to and with the Assignee, its successors and assigns, that the Assignor, its successors and assigns, shall and will, at the expense of the Assignee, do all lawful acts and things and make, execute (which execution will not be at Assignee's expense) and deliver any and all other instruments in writing, further applications, any necessary powers of attorney, papers, affidavits, assignments, and other documents which may reasonably be required or necessary to secure and vest in the Assignee, its successors and assigns, the Assignor's entire right, title and interest in and to the Marks and/or all of the rights, titles, benefits, privileges, and advantages hereby sold, assigned, transferred and conveyed;

AND the representations, warranties, covenants and agreements contained in the

Purchase Agreement shall not be superseded or expanded hereby but shall remain in full force and effect to the full extent provided therein.

This instrument and all of its terms shall inure to the benefit of and shall bind the Assignor and the Assignee and their respective successors and assigns.
