TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 30, 2011, is made by Wells Fargo Bank, National Association, as Administrative Agent (the "Secured Party").

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, dated as of July 31, 2009, by and among the Secured Party, Center for Diagnostic Imaging, Inc., a Minnesota corporation (the "Grantor"), and certain other parties thereto, the Grantor has granted a security interest in certain personal property to the Secured Party, including without limitation a security interest in certain trademarks, trademark applications, and/or trademark licenses ("Trademarks");

3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.
