**1. Assignment of Rights; Consideration.**

In consideration of the value received by Assignor which is set forth in the Separate Agreement, Assignor hereby assigns, grants, transfers, sells and conveys to Assignee all of Assignor's right, title and interest of every kind and nature throughout the world in perpetuity in and to all of the Nival Trademarks owned by, registered to, or previously assigned to Assignor.


**2. Additional Rights.**

registrations, renewals and/or extensions, (b) to sue for all past, present or future infringements or other violations of any rights in the trademarks, and (c) to settle and retain proceeds from any such actions).


